NOTIFICATION
(SALES TAX)

S.R.O. 472(I)/2009.— In exercise of the powers conferred by clause (c) of section 4 of the Sales Tax Act, 1990, the Federal Government is pleased to direct that the following further amendments shall be made in its Notification No. S.R.O. 549(I)/2008, dated the 11th June, 2008, namely:—

In the aforesaid Notification,—

(1) In column (1), for serial number 3 and the entries relating thereto in columns (2) and (3) the following shall be substituted, namely,—

“3. Plant, machinery and equipment whether manufactured locally or imported except those specified in Annexure to this Notification.	Import and supply thereof.”;

(2) against serial number 4, in column (1),—

(a) in column (2), clauses (xxxi), (xxxii) and (xxxiii) shall be re-lettered as sub-clauses (a), (b) and (c) of clause (xxx), respectively; and

(b) clauses (xxxiv), (xxxv), (xxxvi) and (xxxvii) shall be renumbered as clauses (xxxi), (xxxii), (xxxiii) and (xxxiv), respectively;

(3) against serial number 7 in column (1), in column (3), after the word “manufacturer.”, at the end, the words, commas, figure and brackets “and in case of imported components, sub-components and parts, all the conditions, restrictions, limitations and procedures as are imposed by notification under section 19 of the Customs Act, 1969 (IV of 1969), shall apply” shall be inserted;

(4) after serial number 8 in column (1), the following new serial number and entries relating thereto in columns (1), (2) and (3), shall be added, namely:—

“9. Wheel chair. 8713.1000 and 8713.9000.”; and

(5) after the Table, the following Annexure shall be added, namely:--
